**Research focus:** My research activities are currently focused on the analysis and assessment of the social, economic, political, and technological impacts of the transition from the “linear economy” to a “circular economy”. My research interests include regional economic development, European policies, European economic integration, migration studies, social movements, the sharing economy, and research methodologies in economic geography.
